

## **Program Delivery Agreement**

Between Hibbing Community College and  
Bemidji State University Department of Nursing

### **Statement of Purpose**

Hibbing Community College (HCC) and Bemidji State University (BSU) enter this agreement to provide for student articulation from the Associate Degree in Nursing, offered at HCC, to the Baccalaureate Degree with a major in Nursing at BSU via the use of interactive television (ITV). It is further recognized that the attached schedule of courses, requiring use of the ITV systems at both colleges, is acceptable. This agreement identifies all required courses that will use the ITV system by semester and year with the recognition that reasonable accommodation will be made by both institutions.

### **Terms of the Agreement**

#### **Bemidji State University Responsibilities**

Baccalaureate student application, enrollment, registration and all program administration.

Course delivery of the Baccalaureate Degree with a major in nursing as scheduled.

Use of the BSU ITV facilities and staff to deliver the program.

#### **Hibbing Community College**

Provide for BSU nursing student use of the library.

Collaboration on scheduling and commitment to priority use by the BSU Department of Nursing according to the agreed upon course schedule.

Use of the HCC ITV facilities to serve as a delivery site for the BSU Baccalaureate Degree program.

#### **Collaboration Practices**

Faculty at both institutions will cooperate in scheduling course offerings in a convenient, flexible manner. The resources of both institutions, including faculty and space, will be used in a manner that enhances the educational opportunities available to students.

Both institutions will inform potential students about this program.

#### **Articulation Implementation and Agreement Review**

The Chief Academic Officer or designee of the collaborating institutions, shall be responsible for implementing this agreement, for identifying and incorporating any changes into subsequent agreements, and for conducting annual reviews of this agreement. Modification or changes in the agreement require written notification and agreement to the changes by both parties.

This agreement becomes effective on August 15, 2000 and remains in effect until August 15, 2003 unless terminated or amended by either party with prior written notice.
